संदीप महात्रे पर हुए हमले के सिलसिले में दो लोगों को हिरासत में लिया गया है, जिनमें से एक को वारदात स्थल पर पकड़ा गया था। रविवार रात हुए हमले में महात्रे को मामूली चोटें आई हैं।

तीदार ने बताया कि पूर्व भाजपा निगम पार्षद के पति एवं सामाजिक कार्यकर्ता महात्रे पर हमला उस वक्त हुआ, जब यह थाना क्षेत्र में स्थित अपने कार्यालय में काम कर

रहे थे। वरिष्ठ निरीक्षक ने बताया कि एक कुल्हाड़ी और एक रिवॉल्वर से लैस दो लोग उनके कार्यालय में घुस गये और उन्हें घसीट कर बाहर निकाला तथा हमलावरों में से एक ने भाजपा कार्यकर्ता पर वार किया। उन्होंने बताया कि एक हमलावर को कार्यालय में और आसपास मौजूद लोगों ने पकड़ लिया। उसके सहयोगी को बाद में हिरासत में ले लिया गया।
